Matariki Advisory Group: Establishment, Appointments and Terms of Reference

Portfolios Māori Crown Relations Te Arawhiti / Workplace Relations and Safety

On 14 December 2020, Cabinet:

- 1 **noted** that the Minister for Māori Crown Relations: Te Arawhiti and the Minister for Workplace Relations and Safety (the joint Ministers) intend to form a Matariki Advisory Group (the Group) to:
 - 1.1 determine a date for a Matariki public holiday;
 - 1.2 provide a forward annual calendar for this holiday for the next thirty years to 2052;
 - 1.3 determine how best to celebrate Matariki by marking its importance in an appropriate manner;
- 2 **noted** the draft Terms of Reference for the Matariki Advisory Group, attached under CAB-20-SUB-0533;
- 3 **noted** that the joint Ministers intend to appoint the following members to the Matariki Advisory Group for terms of eighteen months each, commencing on the date of appointment:
 - 3.1 Professor Dr Rangiānehu Mātāmua (Chair);
 - 3.2 Hoturoa Barclay-Kerr;
 - 3.3 Victoria Campbell;
 - 3.4 Dr Pauline Harris;
 - 3.5 Dr Ruakere Hond;
 - 3.6 Rereata Makiha;
 - 3.7 Jack Thatcher;
- 4 **agreed** to the establishment of a Matariki Advisory Group;
- 5 **authorised** the joint Ministers to make changes to the Terms of Reference to the Group's membership as required to ensure it can achieve its purpose;
